



Terms and Conditions

“Face painting” event and “Easter egg drawing” event are organized by SJM Resorts, Limited (“SJM”) at Grand Lisboa Palace. For the purposes of these events, “SJM” and “Grand Lisboa Palace” shall mean SJM Resorts, Limited, GLP Hospitality Services Limited or other subsidiaries of SJM (“SJM Group”).

1. By participating in the event, the guest hereby confirms that he/she agrees to all the terms and conditions listed below, as well as all the rules and regulations set out by “Face painting” and “Easter egg drawing”.
