### Terms and Conditions

1. By registering to the classes, the participant (or the parent/ guardian of participant under 18 years of age) hereby confirms that s/he agrees to all the terms and conditions listed below.
2. For the participants' age requirements of each classes, please refer to the official website of "AI Wonderland Classes".
3. Participants must pay the fee within 48 hours after making a reservation by telephone or after receiving the payment link, otherwise the reservation will be automatically canceled. Workshop spaces are limited, reservation is only confirmed upon full payment on a first-come, first-served basis. There is no refund or exchange once the participant's purchase has been made.
4. Participants must present the original ticket or confirmation letter at the AI Wonderland entrance. Ticket will not be replaced or accepted if lost, damaged or stolen.
5. Participants need to register 10 minutes before the class at the activity venue, admission will be stopped 15 minutes after the workshop starts.
6. If the classes is cancelled by SJM RESORTS, S.A. ("SJM"), SJM will either issue a full refund within 60 days or exchange the ticket for another ticket of the same value.
  - 6.1 Refunds will be returned through the original form of payment used.
  - 6.2 There is no refund or exchange if the classes' cancellation occurs after 15 minutes upon the commencement of the relevant session.
7. Classes will provide required material and tools to all participants. All workshop materials are non-edible.
8. Participants are solely responsible for their own belongings, SJM will not assume liability for any damage to or loss of property.
9. Participants appearing intoxicated, using foul/abusive language, or displaying overt rowdiness must immediately leave the premises without refund or compensation.
10. Photography must be conducted without disruption to other participants and the classes. Audio and video recording must be consented by SJM in advance.
11. The participant shall indemnify and hold SJM harmless against all actions, claims, and demands by any person who suffers or sustains any injury, loss, damage, to property or person, or death arising from or as a result of the participant's gross negligence or willful misconduct.
